Client Agreement:

We agree to provide our service to you on the following terms. These terms constitute a legally binding contract between you and Haddon Pet Services.

What we will do for you:

We agree to provide our services in a reliable, caring and trustworthy manner.

What you agree to do:

You agree to pay the rates that are in effect at the time your pet is in our care. Payment must be made within 7 days of receipt of invoice. Haddon Pet Services reserve the right to charge 8% interest for overdue invoices and for any expenses we incur in chasing overdue invoices.

You agree to provide at least 48 hours notice of cancellation. If less than 48 hours notice is given you agree to pay 20 percent of the total cost of booking. If less than 24 hours notice is provided for a cancellation, then you may be charged in full.

You agree to provide us with all the information necessary for the satisfactory performance of our services, including any dietary, nutritional or exercise requirements of the pet and any other instructions for the wellbeing of the animal. Haddon Pet Services accept no liability where the information provided is incorrect.

You are responsible for supplying the necessary, safe equipment and supplies needed for care of your animals. Haddon Pet Services accept no liability if the equipment provided by you becomes faulty and we reserve the right to charge for any equipment we have to provide and pay for.

You authorise us to obtain any emergency veterinary care that may be necessary during the time spent with your pet. Every effort will be made to contact you prior to veterinary emergency assistance. You accept responsibility for any charges related to this emergency care. You authorise us to use our own vet should it be needed.

You agree to pay for additional fees for providing emergency care, as well as any expenses incurred for unexpected visits, transportation, housing, equipment, food and supplies.

You will be responsible for any medical expenses and damages resulting from an injury to the pet sitter or other persons by the pet. You also agree to indemnify us in the event of a claim by any other person injured by the pet.

Your Pet

We require that your pet is up to date with all vaccinations, worming and flea treatments. We reserve the right to terminate our services without compensation should it transpire that your dog is not up to date with the correct treatments.

We reserve the right to terminate this contract at any time if we (Haddon Pet Services) consider that the owner's animal poses a danger to the health and safety of itself, other pets, or any persons.

We do not accept responsibility for security of your premises or loss if we have access to your property to pick up or drop of dogs during the term of this agreement. We will only undertake pick up and drop off of your dog if prearranged with you, and keys will be provided by you for this purpose only.

If you have given permission for your dog to be walked off lead, you will not hold us liable for any damage, loss or injury if your dog runs away.

We are not responsible for damage caused by a pet escaping because of a faulty lead, collar or harness, equipment that is not properly fitting.

We shall not be held responsible for any damage to property caused by your pet whilst it is within our care. We reserve the right to charge you for replacement/repair caused by damage by your pet during the duration of its stay.

You understand that there is always a risk of injury to dogs that are on walks with other dogs or boarding with other dogs. You agree not to hold Haddon Pet Services responsible for any incident outside of our control.
